

Program Terms & Conditions

The following definitions and terms and conditions (T&Cs) apply to BASF Programs

Definitions

- **Adjusted EDI** is Package Net EDI +/- package Transfers (for independent Retailer) and Package Net EDI (for Distributor-Owned Retailer).
- **Affiliate** is any entity that directly or indirectly controls, is controlled by, or is under common control with BASF or Your legal entity, as applicable. Control exists where an entity owns or controls 50% or more of the voting stock of, or interest in, another entity.
- **AIP (Available Internal Product)** is beginning inventory + Invoiced Purchases – Wholesale EDI.
- **BASF** means BASF Corporation on behalf of itself and on behalf of its Affiliates that sell and provide Products. As of November 1, 2025, BASF Corporation assigns all rights, obligations, and liabilities of BASF Corporation to BASF Agricultural Solutions US LLC. As of that date, all references to “BASF Corporation” and “BASF” shall be referred to as “BASF Agricultural Solutions US LLC” and “BASF” as the context requires.
- **Bulk Net Sales** is bulk beginning inventory + SAP Bulk Orders from a Distributor +/- bulk Transfers - bulk ending inventory.
- **Bulk Order** is an order of a bulk SKU processed through a Distributor, that will ship from BASF directly to the Retailer or Distributor’s warehouse location.
- **Distributor (You or Your** when pertaining to a Distributor Program) is a BASF authorized distributor with a signed BASF distributor agreement currently in effect.
- **Distributor-Owned Retailer (You or Your** when pertaining to a Distributor Program) is treated as a Distributor under the Distributor-Specific Program T&Cs and when pertaining to a Retail Program is treated as a Retailer under the Retailer-Specific Program T&Cs. Refer to the applicable Program document for clarification.
- **EDI** is Product purchased by an independent Retailer from a Distributor - returns to a Distributor and the sale of Product by a Distributor-Owned Retailer to a Grower - returns from a Grower.
- **Grower (You or Your** when pertaining to a Grower Program) is a valid end-user as defined in the [Program Stewardship Q&As](#).
- **Grower L1** is an individual Grower that rolls up to a Grower L3, as specified in the BASF end-user hierarchy (available upon request to Your designated BASF Representative).
- **Grower L3** represents all Grower L1s within a Grower operation, as specified in the BASF end-user hierarchy (available upon request to Your designated BASF Representative).
- **Invoiced Purchases** is Distributor’s purchases from BASF through BASF’s SAP system.
- **Net Purchases** is (beginning inventory - ending inventory) x Distributor List Price + Invoiced Purchases.
- **Net Sales** is Bulk Net Sales + Package Net Sales.
- **OT** is a Retailer outlet location as specified in the BASF retail hierarchy (available upon request to Your designated BASF Representative).
- **OU** is a Retailer operating unit location as specified in the BASF retail hierarchy (available upon request to Your designated BASF Representative).
- **Package Net EDI** is package EDI purchases - package EDI returns (for independent Retailer) and Grower package sales - Grower package returns reported through BASF’s collection tool (eBiz) (for Distributor-Owned Retailer).
- **Package Net Sales** is package beginning inventory + Package Net EDI +/- package Transfers - package ending inventory (for independent Retailer) and Package Net EDI (for Distributor-Owned Retailer).
- **Prohibited POS** is reported POS to a known reseller as determined in BASF’s sole discretion.
- **Personal Information** is information or data that may identify or be reasonably capable of identifying an individual, person, household, or location where individuals reside and any data related to that individual, person, household, or location, and any other information defined as personal information under applicable law.
- **POS or Valid POS** is the transactional data reported by a Retailer that details the Grower purchase and meets BASF reporting guidelines as set forth in the [Program Stewardship Q&As](#).
- **Product** is material sold or distributed by BASF including Participating Brands (as defined in the Program).
- **Program** is the applicable BASF program for which an incentive may be earned on Products if certain qualifications, if any, are met in compliance with the applicable T&Cs.
- **Program Period** is the applicable time period in which the Program is in effect.
- **Program Stewardship Q&As** is the Program stewardship questions and answers found at bit.ly/BASF-Program-Stewardship and is hereby incorporated into these T&Cs by reference as though fully set out.
- **Qualified Adjusted EDI** is Package Net EDI +/- package Transfers - package Prohibited POS (for independent Retailer) and Package Net EDI - package Prohibited POS (for Distributor-Owned Retailer).
- **Qualified Adjusted Net Sales** is the sum of:
 - a. Independent or Distributor-Owned Retailer bulk: beginning inventory + SAP purchases - SAP credits +/- Transfers - ending inventory - Prohibited POS
 - b. Independent Retailer package: EDI purchases from Distributors - EDI returns to Distributors +/- Transfers - Prohibited POS
 - c. Distributor-Owned Retailer package: EDI sales to Growers - EDI returns from Growers - Prohibited POS
- **Qualified Adjusted Purchases** is Qualified Adjusted EDI + SAP Bulk Orders from a Distributor +/- bulk Transfers - bulk Prohibited POS.
- **Qualified POS** is reported, valid POS that can be substantiated by Net Sales. The comparison occurs at OU/brand level.
- **Retail EDI** is (electronic reported sales to Growers - electronic reported returns from Growers) x Program Redemption Price to Growers from a Distributor-Owned Retailer.
- **Retailer (You or Your** when pertaining to a Retailer Program) is a BASF Authorized Retailer, BASF Authorized Seed Retailer, agent, or subagent as defined in the [Program Stewardship Q&As](#). Retailer includes both independent and Distributor-Owned Retailers as noted on the applicable Program document.
- **Seed Zones** are attached as Appendix A for cotton seed and soybean seed.
- **Total EDI** is Wholesale EDI + Retail EDI.
- **Transfers** are valid Product transfers reported through the BASF transfer tool.
- **Wholesale EDI** is (electronic reported sales - electronic reported returns) x Program Redemption Price from a Distributor to an independent Retailer.
- **You or Your** refers to the applicable Distributor, Distributor-Owned Retailer, Retailer, or Grower to whom the Program applies.

Program Terms & Conditions

The following definitions and terms and conditions (T&Cs) apply to BASF Programs

General T&Cs

These General T&Cs apply to all associated Programs. In addition to these General T&Cs, additional Retailer (Page 3), Grower (Page 4), and Distributor (Page 5) Program-Specific T&Cs also apply to their respective BASF Distributor, Retailer, and Grower Programs.

1. **Right to Interpretation:** BASF reserves the right to interpret any Program qualifications or T&Cs, if any, in its sole judgement and cancel or modify any Program at any time without any notice to You.
2. **Right to Audit:** BASF reserves the right to audit all Program claims for incentives, supporting data, and records and reserves the right of final decision on any and all incentives due. Your sufficiently detailed and pertinent records, as determined by BASF in its discretion, shall therefore be made available, upon request, to BASF or its independent accountant to evaluate and verify compliance with the T&Cs of any Program. BASF may also, upon reasonable advance written notice to You, inspect facilities where Product is sold and/or stored, as applicable. If BASF or its independent accountant (in its sole judgment) discovers any false, misleading, inconsistent, or inaccurate information as part of its audit or inspection, then BASF reserves the right to withhold all benefits, incentives, and rewards under any impacted Program, until any identified discrepancies are resolved to BASF's satisfaction. When a discrepancy has been identified, failure to resolve the discrepancy to BASF's satisfaction and/or refusal to permit BASF or its independent accountant to perform an audit under any Program shall result in forfeiture of any incentive that might otherwise be earned but for the discrepancy. If You are found to have submitted false or fraudulent information, You shall also be responsible for the costs associated with any audit conducted by BASF. Any false or fraudulent information given by You or on Your behalf to BASF or its independent accountant or transactions (including inventory movements) that are made with the object to manipulate Program incentives will result in forfeiture of any and all incentives related to or based upon such information or transactions. Additionally, any failure to comply with an audit may result in the loss of Authorized Retailer or Authorized Seed Retailer status, as applicable.
3. **Overpayment:** If BASF reasonably believes an overpayment of incentives has or may occur as a result of any Program, then BASF has the option of reducing the incentive under any Program without notice to You.
4. **Offset:** BASF reserves the right to apply and/or offset any incentive prepaid by or owed to You against any payment owed to BASF or its Affiliates by You and/or Your Affiliates, regardless of whether or not the amounts involved arose out of the same transaction or unrelated transactions.
5. **Assignment:** BASF reserves the right to assign BASF obligations (including the obligation to pay incentives), in whole or in part, under any Program to an Affiliate or a third party without notice to You and without Your consent. You may not assign any incentive that may become due hereunder to any third party without BASF's prior written consent, which may be withheld at BASF's sole discretion.
6. **Legal Compliance:** You represent and warrant that You shall comply with all applicable state, local, federal, and provincial laws and regulations for the collection and sharing of Personal Information which is provided to or acquired by You or Your legal entity in connection with any Program. You acknowledge that certain Grower information may be Personal Information under federal, state, local, or provincial laws or regulations. You understand that individuals may have certain rights under applicable federal, state, local, and provincial laws. Any requests to exercise those rights must be made in writing and may require additional documentation to verify the identity of the individual making the request. BASF will only honor requests for correction of Personal Information if information confirming the accuracy of the new Personal Information can be verified. In the event a regulation, law, or agency requires the deletion of Personal Information and such request for deletion is communicated to BASF, You acknowledge the following:
 - a. **Retailer / Distributor Program:** Any Personal Information requested to be deleted that then impacts the designation of a sale being a "Grower" sale will remove such Grower from the incentive calculations under Your respective Program.
 - b. **Grower Program:** Any request to delete Your Personal Information will withdraw You from the Grower Program and make You ineligible to participate in the Program.
7. **Governance:** All issues, questions, or disputes concerning or arising under the construction, validity, enforcement, or interpretation of any Program and/or the Program T&Cs shall be governed by, and construed in accordance with, the laws of the State of North Carolina, without giving effect to any choice of law or conflict of law rules or provisions. Any legal suit, action, dispute, or proceeding arising out of or relating to any Program and/or these Program T&Cs shall be commenced in a federal or state court located in the State of North Carolina.
8. **References:** In the Program T&Cs, except as the context clearly requires, all references to the singular shall include the plural and vice versa and the term "including" shall mean "including without limitation."
9. **Trademarks:** Participating BASF brands are trademarks or registered trademarks of BASF.

The following definitions and terms and conditions (T&Cs) apply to BASF Programs

Retailer Program-Specific T&Cs

In addition to the General T&Cs (Page 2), these Retailer Program-Specific T&Cs shall also apply to all associated Retailer Programs. Capitalized terms used but not defined herein shall have the respective meanings given to them in the Definitions (Page 1).

1. **Eligibility:** Only Your purchases of Product from a Distributor or Transfers are eligible for Program incentives. Additionally, for seed Product, such purchases must be under a duly executed and valid applicable technology use agreement, and You must have a signed agreement with BASF which permits You to resell the seed Product.
2. **Geography:** Unless otherwise stated in the Program, the Program is effective for all states in the United States. Geography will be based on Your physical address as set forth in the BASF customer database. If no physical address is present Your mailing address will be used to make this determination.
3. **Bulk Product:** Bulk Product provided by BASF will be owned by BASF until invoiced to Distributor, at which time the bulk Product will be owned by Distributor until further invoiced to You. Distributor shall assume all risk of loss or damage to bulk Product from BASF's designated point of shipment until sold to You. BASF expects that You and/or the Distributor will ensure that reasonable care will be exercised to store, secure, and safeguard the bulk Product during the time when it is in Your or the Distributor's care, custody, and control, as applicable. Changes to the named Distributor are not permitted for bulk Product shipments that have been previously delivered. Actual bulk Product delivery date is determined at the discretion of BASF.
4. **POS Reporting:** You must report POS data for all Product, transferred from You, and sold to Growers, for the Program Period. Only POS data reported by You that meets all Program qualifications (if any) and deadlines, contains all required information, and is submitted through approved collection tools as defined in the [Program Stewardship Q&As](#) will be eligible to earn Program incentives. If You submit noncompliant POS transactions or Prohibited POS, such transactions will be declared invalid, You will be required to repay any applicable incentives arising out of or in connection with such transactions. Additionally, at BASF's sole discretion (a) You may be required to pay liquidated damages and/or (b) You may lose Authorized Retailer status.
5. **Inventory Reporting:** You must submit ending inventory volumes to Your local BASF Representative by October 19th immediately following the Program Period to earn Program incentives. Package inventory volumes are to be submitted at the OU level for each Product. Repack volumes should be included in package inventory. Bulk inventory volumes are to be submitted at the OT level for each Product. Failure to have inventories reported to BASF will result in Net Sales equal to zero and a decrease in Program incentives. For Retailers with Qualified Adjusted Net Sales equaling less than \$100,000 in the Program Period, inventory reporting is not required; instead, the inventory calculation will be beginning inventory + Adjusted Purchases - POS = ending inventory.
6. **Out of Variance Recovery:** Any incentive made to the Grower on POS that exceeds Qualified POS is subject to recovery by BASF from You. The recovery amount will be defined by BASF and recovered from any incentives owed to You by BASF. Any incentives that cannot be recovered under the current Program Period incentive will be carried forward until recovery is complete.
7. **Inspection Authorization:** By cashing a Grower Program check Retailer agrees (A) to provide authorization of all appropriate request forms as required by the Farm Service Agency (FSA), Risk Management Agency (RMA), and any other agencies that BASF may require and (B) to allow BASF or its agent for a period of one year following the date the incentive check was issued, and without the requirement of further authorization or consent, to inspect and obtain copies of any and all: (i) FSA crop reporting information on any land farmed by the Grower, including, but not limited to, Summary Acreage History Report, Form 578, and any corresponding aerial photographs; (ii) RMA documentation relating to any crops farmed by the Grower; (iii) any and all original dealer and Retailer invoices and related cash payments for Product purchased by or for the Grower; and (iv) any and all original records or documents covering or relating to the storage, sale, use, or transfer of Product. Grower and You agree that such records or documents, if requested, should be compiled and provided to BASF or its agent in an organized manner for inspection.
8. **Net Negatives:** When specified, BASF will review all Your Product purchases and returns after the applicable deadline through the end of the Program Period. If more Product is returned than purchased, those Net Negatives will reduce the applicable Program qualification and incentive metrics.
9. **Grower Claims Program Deduction:** Unless otherwise stated in the Program, crop loss incentive or replant incentive will have the corresponding Product quantity or dollar amount deducted from all other Program qualifications and incentives.
10. **Incentive Calculations:** Unless otherwise stated in the Program, BASF's published Program Redemption Price for the Program Period will be used to calculate Program qualification (if any) and incentive.
11. **Incentive Issue Date:** Unless otherwise stated in the Program, the incentive will be issued on or about December 21st immediately following the Program Period so long as earnings are at least \$5,000 across all Your Programs for the Program Period.
12. **Returns:** You should not accept returns from Growers of Product sold after September 30th of the Program Period; if You accept such a return, any incentives that corresponds to such returned Product shall be deducted from any incentive otherwise due to You by BASF.

The following definitions and terms and conditions (T&Cs) apply to BASF Programs

Grower Program-Specific T&Cs

In addition to the General T&Cs (Page 2), these Grower Program-Specific T&Cs shall also apply to all associated Grower Programs. Capitalized terms used but not defined herein shall have the respective meanings given to them in the Definitions (Page 1).

- 1. Eligibility:** Only Your purchases of Product from a Retailer who purchases from a Distributor or Transfers are eligible for Program incentives. Additionally, for seed Product, such purchases must be under a duly executed and valid applicable technology use agreement.
- 2. Geography:** Unless otherwise stated in the Program, the Program is effective for all states in the United States. Geography will be based on the Grower L1 physical address as set forth in the BASF customer database. If no physical address is present the Grower L1 mailing address will be used to make this determination.
- 3. Eligible Acres:** You may only receive incentive for Product used on acres that are owned and/or controlled by You as identified on Your invoice. Your identification on Your invoice must be the same across all Your invoices to be eligible for Program incentives. Individual Growers may not aggregate their collective Product purchases to qualify for any Program incentive, unless expressly authorized within the Program.
- 4. Personal Information:** If You request BASF or the entity collecting Your Personal Information for purposes of the Program delete Your Personal Information, then You shall no longer be eligible for Program incentives. If You request BASF or the entity collecting Your Personal Information for the purposes of the Program to correct Your Personal Information, then you understand you may no longer be eligible for Program incentives if the correction disqualifies You. Your disqualification will be effective as of the date of the request for deletion or correction and will be retroactive to the first day of the Program Period.
- 5. Out of Variance Recovery:** Any incentive made to You on POS that exceeds Qualified POS is subject to recovery by BASF from the Retailer. The recovery amount will be defined by BASF and recovered from any incentives owed to the Retailer by BASF. Any incentives that cannot be recovered under the current Program Period incentive will be carried forward until recovery is complete.
- 6. Inspection Authorization:** By cashing a Grower Program check Your Retailer agrees (A) to provide authorization of all appropriate request forms as required by the Farm Service Agency (FSA), Risk Management Agency (RMA), and any other agencies that BASF may require and (B) to allow BASF or its agent for a period of one year following the date the incentive check was issued, and without the requirement of further authorization or consent, to inspect and obtain copies of any and all: (i) FSA crop reporting information on any land farmed by You, including, but not limited to, Summary Acreage History Report, Form 578, and any corresponding aerial photographs; (ii) RMA documentation relating to any crops farmed by You; (iii) any and all original dealer and Retailer invoices and related cash payments for Product purchased by or for You; and (iv) any and all original records or documents covering or relating to the storage, sale, use, or transfer of Product. Retailer and You agree that such records or documents, if requested, should be compiled and provided to BASF or its agent in an organized manner for inspection.
- 7. Grower Claims Program Deduction:** Unless otherwise stated in the Program, crop loss incentive or replant incentive will have the corresponding Product quantity or dollar amount deducted from all other Program qualifications and incentives.
- 8. Incentive Calculations:** Unless otherwise stated in the Program, BASF's published Program Redemption Price for the Program Period will be used to calculate Program qualification (if any) and incentive.
- 9. Incentive Issue Date:** Unless otherwise stated in the Program, Your incentive will be issued on or about November 30th immediately following the Program Period so long as earnings are at least \$250 at the Grower L3 level and at least \$100 at the Grower L1 level across all Grower Programs for the Program Period.
- 10. Returns:** Retailer should not accept returns from You for Product sold after September 30th of the Program Period; if the Retailer accepts such a return, any incentives given to You that corresponds to such returned Product shall be deducted from any incentive otherwise due to the Retailer by BASF.

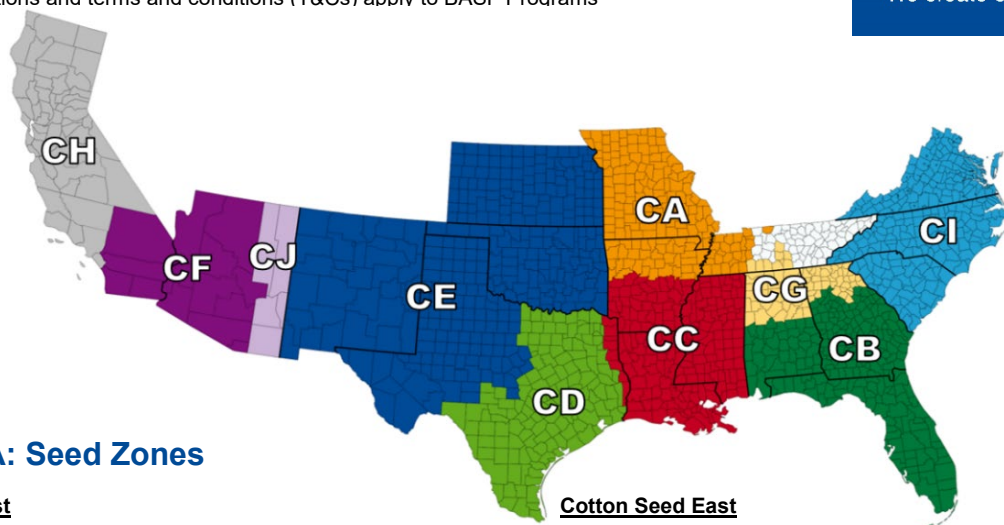
Distributor and Distributor-Owned Retailer Program-Specific T&Cs

In addition to the General T&Cs (Page 2), these Distributor and Distributor-Owned Retailer Program-Specific T&Cs shall also apply to all associated Distributor and Distributor-Owned Retailer Programs. Capitalized terms used but not defined herein shall have the respective meanings given to them in the Definitions (Page 1).

- 1. Eligibility:** Only Total EDI of Product purchased directly from BASF by You, if Your accounts are current at the time incentives are issued, is eligible for Program incentives.
- 2. Geography:** Unless otherwise stated in the Program, the Program is effective for all states in the United States.
- 3. Bulk Product:** Bulk Product provided by BASF will be owned by BASF until invoiced to You, at which time the bulk Product will be owned by You until further invoiced to the Retailer. You shall assume all risk of loss or damage to bulk Product from BASF's designated point of shipment until sold to the Retailer. BASF expects that You and/or the Retailer will ensure that reasonable care will be exercised to store, secure, and safeguard the bulk Product during the time when it is in Your or the Retailer's care, custody, and control, as applicable. Changes to the named Distributor are not permitted for bulk Product shipments that have been previously delivered. Actual bulk Product delivery date is determined at the discretion of BASF.
- 4. Inventory Reporting:** All Total EDI and Product inventory for the Program Period must be submitted via electronic reporting based on BASF specifications. Electronic reporting (EDI/XML) is the method of reporting sales and inventory via AgGateway industry standards. Inventory transactions for the previous month are due by the 8th of each month. Sales transactions for the previous month are due by the 10th of each month. At the end of the Program Period, all sales will be totaled for the Distributor.
- 5. End-of-Season Transactions:** End-of-season transactions are due the 1st Monday in October immediately following the Program Period. End-of-season reconciliation reports will be distributed by BASF to You on the following Wednesday. Confirmation of reconciliation or communication of issues is due from You to BASF by the 3rd Monday in October following the Program Period. Completion of reconciliation of all data is due from You to BASF by October 31st following the Program Period.
- 6. EDI Reconciliation:** BASF will review and compare Net Purchases and Total EDI by Distributor/Brand/SKU, any differences may result in a reduction of Program incentives.
- 7. Grower Claims Program Deduction:** For Distributor-Owned Retailer Program, unless otherwise stated in the Program, crop loss incentive or replant incentive will have the corresponding Product quantity or dollar amount deducted from all other Program qualifications and incentives.
- 8. Incentive Calculations:** Unless otherwise stated in the Program, BASF's published Distributor List Price for the Program Period will be used to calculate Program qualification (if any) and incentive.
- 9. Incentive Issue Date:** Unless otherwise stated in the Program, the incentive will be issued on or about December 21st immediately following the completion of the Program Period.
