FiberMax® One Ton Club™ Sweepstakes – Official Rules

1. Produce a minimum of 2,000 pounds of ginned cotton per acre on a minimum of 20 acres planted with FiberMax cotton between January 1, 2021, and December 31, 2021;
2. Cotton acreage can be either Irrigated or Dryland;
3. Plant 100% FiberMax cotton on the 20 qualifying acres;
4. Provide gin recap sheets to verify 2,000 lb/A yield by February 28, 2022

Employees, contractors, directors, officers and agents of BASF ("Sponsor"), MorganMyers, Inc., and each of their parent, affiliates, subsidiaries, distributors, sales representatives, and advertising, promotion and judging agencies and all other service agencies involved with the Sweepstakes, and members of the immediate family (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and household of each such employee (whether or not related) are not eligible to enter or win.

Then, complete the registration form with all requested information (including, but not limited to, your name, address, date of birth, email address, gin recap sheets to verify 2,000 pounds per acre yield of qualifying acres (minimum of 20 acres planted with 100% FiberMax cotton), confirmation that applicable cotton is registered in the Certified FiberMax Cotton program and any other information requested by the Sponsor). Then, submit your fully completed registration form along with any other required documentation by either: mailing it to BASF, Attn: FiberMax One Ton Club, P.O. Registration forms submitted via fax, email or online application must be received by February 28, 2022, to be eligible. Registration forms submitted via mail must be postmarked by February 28, 2022, and received by March 7, 2022, to be eligible. Limit: One (1) OTC registration form per person/email address during the entire Entry Period, regardless of how you access the Qualification registration forms. **YOU WILL NOT RECEIVE AN ENTRY INTO THE SWEEPSTAKES UNTIL AND UNLESS YOU ATTEND THE GRAND PRIZE EVENT (AFTER RECEIVING AN INVITATION) AND YOU HAVE BEEN VERIFIED BY SPONSOR AS AN ELIGIBLE ENTRANT.**

Sponsor reserves the right to audit acres/yard reported in any entrant's registration form to verify eligibility, in Sponsor's sole discretion. Forms by any entrant who is found not to be eligible for this Sweepstakes will be disregarded and will not be eligible for the Grand Prize Event. Ineligible individuals will not receive notification or any correspondence from Sponsor. Entrants who are determined to be eligible for the Sweepstakes will be Sweepstakes entrants and will receive an invitation for the Grand Prize Event, which will be mailed to such entrant at the mailing address provided in the registration form. Sponsor is not responsible for any change of email address, mailing address and/or telephone number of entrants. Sponsor is not responsible for any entrant's failure to receive his/her invitation, regardless of the cause.

By participating in this Sweepstakes and/or the Grand Prize Event, you agree (a) to be bound by these Official Rules; (b) as between you and the Sponsor, that the decisions of the Sponsor is final on all matters relating to the Sweepstakes; (c) you are not participating on behalf of any employer or third party; (d) in the event that you do not comply with these rules, that you will be disqualified and your prize (if any) will be forfeited; and (e) the entrants must be available to participate in the Grand Prize Event and present at the time of the drawing to be considered eligible.
