## **BASF Pollinator Week Sweepstakes**

## **Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. **SEE BELOW FOR DETAILS.** 

1. Eligibility: The BASF Pollinator Week (the "Sweepstakes") is open only to those who are (1) legal residents of the continental United States and the District of Columbia (2) follow the Living Acres Facebook page and (3) at least 18 years of age or the age of majority in the jurisdiction where they reside, whichever is greater, at the time of entry.

Employees, contractors, directors, officers and agents of BASF ("Sponsor"), and each of Sponsor's parent, affiliates, subsidiaries, distributors, sales representatives, and advertising, promotion and judging agencies and all other service agencies involved with the Sweepstakes, and members of the immediate family (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and household of each such employee (whether or not related) are not eligible to enter or win.

This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void outside the United States and where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Sponsor: The Sponsor of the Sweepstakes is BASF Corporation, 26 Davis Drive, Research Triangle Park, NC 27709.
- 3. Sweepstakes Entry Period: The Sweepstakes begins on Monday, June 22, 2020 at 12:00 am Eastern Daylight Time ("ET") and ends on Friday, June 26, 2020 at 5:00 p.m. ET (the "Entry Period"). All entries must be received before the Sweepstakes Entry Period end time/date to be valid.
- **4. How to Enter:** During the Entry Period, you must follow the Living Acres Facebook Page and like or comment on a BASF Pollinator Week Sweepstakes post to be eligible for the Sweepstakes. BASF employees will put all entries into a drawing to win a prize (See sections 6 and 7 below). You may enter only once, and only one entry will be counted for the Sweepstakes. Sponsor and its agents, affiliates, subsidiaries, representatives and service providers may use the personal information submitted with entry for purposes of prize fulfillment and marketing of their products or services. The Sponsor will not sell personal information.

Sponsor is not responsible for lost, late, illegible, misdirected, or incomplete entries, incorrect or inadvertent deletion or filing of an entry; or other errors or malfunctions of any kind whether human, mechanical, electronic or otherwise. Proof of sending or submission of entry will not be deemed proof of receipt by the Sponsor. No facsimiles or mechanical reproductions of entries allowed. Automated entries are prohibited, and any use of automated devices will cause disqualification. Entrants may not enter with multiple identities or entries. Any entrant who attempts to enter under multiple identities or entries, will be disqualified and forfeits any and all prizes won, in Sponsor's sole discretion.

- **5. Entrant Verification:** At the end of Entry Period, Sponsor will review and verify all entries. Any entrant who is found not to be eligible for this Sweepstakes will be disregarded and will not be eligible for any prizes. Ineligible individuals will not receive notification or any correspondence from Sponsor.
- **6. Prize Drawing:** Individuals who do not follow all of the instructions and/or abide by these Official Rules or other instructions of Sponsor may be disqualified. You may enter only once, and only one entry will be counted for the Sweepstakes. The odds of winning depend on the number of eligible entries received.

Grand Prize: There will be one (1) Grand Prize Sweepstakes winner randomly selected from among all eligible entrants — which will be announced at approximately 12:00 p.m. ET on June 27, 2020. The winner will be selected as follows: the Sponsor will, after the Entry Period once Sponsor has reviewed and verified all entries, determine the Grand Prize Winner by randomly selecting one (1) entrant. The entrant whose name is randomly selected will be the potential winner. The method of the random selection will be determined in Sponsor's sole discretion. Grand Prize Winner will be announced on Facebook at approximately 12:00 p.m. ET on June 27, 2020. BASF will contact the winner within one (1) business day of the announcement of the Grand Prize Winner. If winner cannot be contacted, is ineligible or fails to claim the prize and confirm mailing address within seven (7) days from the time award notification was sent, the prize may be forfeited. Sponsor or its agent will mail or electronically deliver the prize, within the continental United States and the District of Columbia.

Secondary Prizes: There will be twenty-five (25) Secondary Prize Sweepstakes winners randomly selected from among all eligible entrants – which will be announced at approximately 12:00 p.m. ET on June 27, 2020. The winners will be selected as follows: the Sponsor will, after the Entry Period once Sponsor has reviewed and verified all entries, determine the Secondary prize winners by randomly selecting twenty-five (25) entrants. A Grand Prize winner will not be eligible for a Secondary Prize. The entrants whose names are randomly selected will be a potential winner. The method of the random selection will be determined in Sponsor's sole discretion. Secondary Prize Winners will be announced on Facebook at approximately 12:00 p.m. ET on June 27, 2020. BASF will contact the winners within one (1) business day of the announcement of the Grand Prize winner. If a winner cannot be contacted, is ineligible or fails to claim the prize and confirm mailing address within seven (7) days from the time award notification was sent, the prize may be forfeited. Sponsor or its agent will mail the prize, within the continental United States and the District of Columbia, to the Sweepstakes winner covering shipping charges. Please allow at least 45 days for delivery of the Secondary Prize.

The Sponsor reserves at its sole discretion the right to not award the prize or to determine an alternate winner in accordance with the Official Rules in the event that a winner has been disqualified, cannot be contacted, or is deemed ineligible for any reason.

As a condition of participating in the Sweepstakes, entrants agree and acknowledge that in order to be deemed the winner, the potential winner agrees to all terms herein, including but not limited to, the Publicity and Personal Information section, or prize may be forfeited.

If the potential winner is disqualified for any reason, the Sponsor reserves the right to determine an alternate winner by conducting a random drawing from among all eligible entrants. By participating in this Sweepstakes you agree (a) to be bound by these Official Rules; (b) as between you and the Sponsor, that the decisions of the Sponsor are final on all matters relating to the Sweepstakes; and (c) in the event that you do not comply with these rules, you will be disqualified and your prize (if any) will be forfeited.

## 7. Prizes:

One (1) Grand Prize Winner will receive a 1-year family level membership to a local museum of their choice, not to exceed US \$200 (inclusive of all fees including but not limited to taxes and shipping). Grand Prize Winner must notify Sponsor, or its agent, of which local museum it wishes to receive a 1-year family level membership so it may be acquired before December 31, 2020. Sponsor or its agent will mail or electronically deliver the prize, within the continental United States and the District of Columbia.

Twenty five (25-Five (25) Secondary Prize Winners will receive a one pollinator seed mix and a garden tool (Estimated retail value of \$30). The pollinator seed mix is a blend of perennial and annual flowers that attracts monarch butterflies, honey bees, bumblebees, and other native pollinators. In the event the seed mix is not permitted to be sent to the entrant for any reason, as determined by Sponsor in its sole discretion, the entrant shall be considered ineligible to receive the seed mix.

Sponsor does not make, nor in any manner is responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to the prize including but not limited to its quality, fitness for purpose or mechanical condition. Winner will be responsible for all fees required in claiming the prize, applicable taxes as well as all other expenses relating to the receipt and use of prize.
